

# **Irregularity Log**



#### **TYPE:**

#### Invalidations

- Accommodation issues
- TA/TP behavior
- Technology issues



## **Troubleshooting**

- Many issues due to Chromebooks not being updated to latest version of Chrome:
  - Did not display fractions, text boxes, or characters correctly.
  - Text boxes did not display or did not allow students to type.
  - Abnormal characters displayed.
- Many students did not have the proper embedded accommodations marked BEFORE enrolling them into a test session.



# **Troubleshooting (continued)**

- Missed deadlines:
  - ACT Accommodations Request is always due in early February.
  - Non-Standard Accommodation window to submit applications always runs from December 1 – February 1.
  - Testing windows are different for CCRA, ACT, and OSTP 3-8.
    - These are always listed on our assessment calendar posted on our <u>home page</u>.

## **ELP Band Exit**

- The Band Exit submission window is tentatively scheduled for August 1-30, 2024.
- Updated guidance and criteria rubrics can be found on OELP's ELP Band Committee Exit Request page.
- OSTP ELA scores for Grades 3-8 will not be available until August due to standard setting this summer.
- Begin working on 3<sup>rd</sup> grade and high school band exits.
- Prepare the paperwork for eligible 4<sup>th</sup>-9<sup>th</sup> graders until scores become available.



## **Alternate ACCESS ELP Band Exit**

- Due to the redesign of Alternate ACCESS, which aligned the assessment with WIDA's English Language Development Framework, 2020 Edition, Alternate ACCESS qualifying scores for band exit requests will be changing.
- Previously, the Alternate ACCESS was scored using an A1-P3 scale.
- The new Alternate ACCESS will be on a 1-5 scale.



## **Alternate ACCESS ELP Band Exit**

 WIDA will provide OSDE with a concordance table in July of 2024 so that equivalent scale scores from the previous Alternate Access and the 2024 Alternate Access can be matched.

# eMetric

## New Features Implemented for Spring 2024

- Practice Tests split by content area/subject
- District level users export Test Status report at district level for all tests under the same content area
- School level users export Test Status report at school level for all tests under the same content area
- The Text-to-Speech ELA accommodation separated out into Reading and Writing
- Users bulk add or edit a Test Report Code



## Changes for Reporting Spring 2024

#### Educator Portal

- Removal of Points Earned and Points Possible from Roster and Individual Student Report (ISR)
- Removal of Lexile and Quantile scores
- Summary level reports and data tools will be available for final release but not for preliminary release

#### Parent Portal

- Removal of Points Earned/Possible from the Performance by Category table
- New Performance Level symbols in the Performance by Category table
- New Ways to Support text and Performance Level Descriptor text for ELA and Math
- Removal of Lexile and Quantile scores
- Summary level data will be available for final release but not for preliminary release

- Updates to student testing devises, as outlined in the technology guide are critical to ensure the proper functionality of the testing platform. This ensures students have the best testing experience.




## Spring 2024 Percentage of Tests Completed



## Test Material Shipments 2024

- CCRA 40 boxes shipped to 22 districts
- OSTP 5,518 boxes shipped to 540 districts
- Improvements
  - ➤ CCRA Test Materials shipped to arrive in districts prior to Spring Break.
- Feedback
  - ➤ Damaged boxes of OSTP manuals reported by 4 districts.
    - Replacement shipments sent



#### **Moving Forward**

- Issue: G3-5 ELA Test Administration Manual, No Passage Tab 2 for G3 and G4
  - You will now read two related passages and answer the questions that follow. Some of these questions may ask you to compare the two passages.
  - Read the passage to yourself. (Pause while students read the passage.)
  - Now click tab 2.
- Moving Forward: Before final test launch, conduct a lastminute walk through of TAM directions. Paired pass grades 4 and 5 only.

#### **Moving Forward**

- Issue: G3-5 Math Test Administration Manual, No Ruler on Sample Items
  - You may see some questions that ask you to use a ruler to measure an object. Click on the ruler tool at the bottom of the screen, and a ruler will appear. To move the ruler, click and drag the ruler to the object you want to measure.

 Moving Forward: Before final test launch, conduct a lastminute walk through of TAM directions to ensure ruler is provided on sample items to practice with.

#### TA and TP Module Training Spring 2024

- Module Training Performance Statistics
  - Course were opened on March 1-May 16th.
  - Cognia closed 32 courses based on reaching/approaching the 1,500 maximum learners enrolled per course.
    - TAT = 22 courses closed
    - TPT = 10 courses closed
  - Enrollments = 51,135
  - Completed Certifications = 45,228
  - We peaked on March 25, enrolling 4,675 learners on that day.

# ACT Statistics



#### SITES:

470 Oklahoma Schools administered The ACT

#### **TESTING:**

- Over 51,400 students successfully tested online
  - 4,844 online sessions completed
  - 376 Total Irregularity Reports logged
    - 2,869 students in those irregularity reports
      - 28 Prohibited Behaviors reports



#### **ACT Accommodations Requests & Statistics**

- 6,359 Accommodation Requests Received
  - Only 502 requests were denied
- 4,842 Requests were approved without supports
  - 840 requests approved with supports
- 855 Requests for EL Supports
  - Only 15 of these requests were denied



#### Top reasons Accommodations Requests are Denied or Only Partially Approved

- 1. A requested accommodation conflicts with a previously or currently approved accommodation and cannot be approved.
- 2. The requested testing accommodation must be regularly used in the classroom for tests, and confirmed on the examinee's IEP, 504 or Official Accommodation Plan for in-school use.
- 3. The accommodations being requested may be provided to the examinee on a locally approved basis during the state or district-wide administration of the ACT.
- 4. The requested accommodation is not listed on the examinee's IEP, 504 Plan or official accommodations plan.



#### **Email Communications**

- ACT sent 9 emails from October through April
- Over 98% of our communications were delivered
- Around 78% of all communications were opened/viewed






- Average total HANDLE times for September – April was 10 minutes 46 seconds per call.
- A total of 1,806 calls from Oklahoma from September to May.



## **Online Testing**

- Overall, a very successful testing experience in Oklahoma
- Nearly all technical issues could have been prevented by completing the site readiness steps according to ACT guidelines
- 35,371 tests were successfully completed the first 2 days of testing
- Oklahoma still leads all ACT contracts with total online testing percentage





Most Common Errors	How To Avoid	
3005 - Another application attempted to take control away from TestNav	Disable all automatic application launching per p. 3 of the Technical Guide.	
1009 - Network Connection issue	While this can happen unexpectedly, ACT has wireless network best practices listed on p. 18 of the Technical Guide to help minimize interruption.	
8026 - Unable to connect to the proctor caching computer. Please contact your administrator.	This can be detected through both the App Check and the Mock Administration.	
3105 - Chromebook attempting to use app but is not in kiosk mode	Follow Chromebook setup instructions, starting on p. 20 of the Technical Guide.	
8029 - App is out of date	Be sure to download the latest version. If the app is already on the student machine, check to ensure it's the latest version.
