# Oklahoma School Testing Program

---

## Introduction

Cognia is pleased to serve as the vendor for the Oklahoma School Testing Program (OSTP) for Grades 3–8. The OSTP will assess student proficiency relative to the Oklahoma Academic Standards (OAS). It is important that the guidelines within this *Test Administration Manual* are adhered to as schools administer the assessment program.

## The Success of the OSTP

Administration of the OSTP is an important professional responsibility. Usefulness of the test results depends on the accuracy of each student's performance. Experience shows that student performance is highly dependent upon the student's motivation and attitude toward the test, the preparedness of the Test Administrator, the physical arrangements for testing, and adherence to clearly provided instructions.

Closely read this manual. All steps for distributing and administering the test materials are essential to the successful standardization of the OSTP. Test Administrators must understand the detailed processes and the roles and responsibilities required of themselves and others for a successful test administration.

## Testing All Students

Oklahoma law states that tests shall be administered to every student enrolled in a tested grade in the public schools of Oklahoma. Every student will be administered all the designated state tests, with or without accommodations, or each student must be administered the Oklahoma Alternate Assessment.

If a student is not tested due to absence, alternate testing, or any other reason, the student demographic information must still be provided to Cognia. This will allow every student who is enrolled in assessed grade levels and contents to be accounted for during testing.

For accountability, federal/state law requires that no less than 95% of students enrolled must be tested.

- A. **IEP/504:** All students on an Individualized Education Program (IEP) or Section 504 Plan are required to participate in state assessments. The IEP or Section 504 Plan team annually determines how students with disabilities will participate in state assessments: with or without accommodations or an alternate assessment. Assessment accommodations are determined based on a student's need and must be outlined in their IEP/504 Plan.
- B. **Absent Students:** Students who are absent during their assigned test administration should be given the tests upon their return to school. **Please provide every absent student an opportunity to make up tests within the state's testing window.** Federal law requires that no less than 95% of students enrolled in each student subgroup be tested.
- C. **Emergency Medical Exemptions:** In the case of a significant medical emergency that would prevent a student from participating in the OSTP, an exemption request may be electronically submitted through the SDE Single Sign-On Accountability Reporting Application. This request must be approved by a review committee at the SDE.
- D. **Suspended Students:** Administrative code no longer requires or permits districts to drop students who are suspended. Instead, suspended students will remain **enrolled** in the district and will be expected to participate in state assessments.

# Test Security—Legal Requirements

All personnel involved in testing share the responsibility for ensuring that all materials and student responses are handled in a secure and confidential manner and in accordance with security mandates and other general procedures. **Test materials should never be left out in unattended areas, reproduced in any manner, or leave the school building without written consent from the SDE.** Violation of regulations can result in revocation of a person’s teaching, counseling, or administrative certificate, and/or other certifications.

## Nondisclosure of Test Contents

**It is prohibited to use secure questions as instructional tools for student “practice”—either verbatim or in re-worded forms.**

Test contents are not to be viewed prior to the testing session by anyone. Once a test session has begun, no one other than the student being tested is allowed to view the test contents on the screen or in the test booklet. For security purposes, all paper test booklets are wafer-sealed. Students are not to disclose test contents to anyone.

*The one exception to this rule is a Test Administrator (TA) who is reading aloud test questions as part of a valid documented accommodation for an IEP, Section 504, or EL student. The TA should read from a separate test booklet that matches the form being administered, or read over the student’s shoulder. The Nondisclosure Agreement (NDA) statement has now been incorporated into the Test Administrator Security Form. It is required that all TAs sign this electronic form. Any TA who is reading aloud test items should also have a Test Proctor (TP) in the room to ensure test security.*

## Smart Technology Devices Policy

Due to test security purposes, test questions and answers may not be recorded, reproduced, or transmitted in any way, within or outside of the testing environment. Cell phones and any other devices that have the capability of recording, reproducing, or transmitting test questions within or outside of the testing location are prohibited.

The presence of student cell phones or other communication devices may result in a breach of test security. It is important that school administrators and staff establish and communicate this policy to parents and students.

# Responsibilities of the Test Administrator

The Test Administrator (TA) must be a certified employee of the school district and cannot be related to the Test Proctor, Roving Proctor, or any student in the test session. The TA must be trained in all testing and security procedures prior to testing to ensure standardization across administrations. This training is provided via the online Test Administrator/Test Proctor Modules; certificates indicating successful completion of the module must be forwarded to the BTC and retained at the district level as the record of training.

## Before Day of Testing:

- Complete the online Test Administrator/Test Proctor Module with a minimum score of 80% on the quiz within the module and a completed attestation at the end of the module. Provide your Building Test Coordinator (BTC) with a digital or printed copy of your training certificate. Contact the Building Test Coordinator (BTC) or District Test Coordinator (DTC) with any test-related issues or questions.
  - **Note: Training modules are available in Canvas on the Cognia Oklahoma Help & Support Site: [oklahoma.onlinehelp.cognia.org](http://oklahoma.onlinehelp.cognia.org)**
- Review Test Security and Validity Rules at [rules.ok.gov/code](http://rules.ok.gov/code). Oklahoma Administrative Code 210:10-13-4
- Remove or cover bulletin boards or posters in the testing site that contain visual aids.
- Preview this *Test Administration Manual* several days prior to testing.
- Review both the *OSTP IEP/504 Accommodations Manual* and the *OSTP EL Accommodations Manual* for guidance and procedural requirements.

### **Before Start of Online Testing:**

- Secure additional materials needed for testing (e.g., pencils, scratch paper, and/or unmarked grid paper).
- If your district chooses, a paper copy of the Reference sheet (for Mathematics) [oklahoma.onlinehelp.cognia.org/reference-sheets](http://oklahoma.onlinehelp.cognia.org/reference-sheets) and the Writer’s Checklist (for ELA writing section) [oklahoma.onlinehelp.cognia.org/writers-checklist](http://oklahoma.onlinehelp.cognia.org/writers-checklist) may be provided for students to use during testing.
- Ensure all proper policies are followed for students who require special accommodations.
- Ensure electronic communication devices are not present while in the test administration site (e.g., cell phones, cameras, smartwatches, etc.).
- Ensure all desks are cleared and that each student has pencils with erasers.
- Calculators are only allowed as an approved accommodation for students on an IEP/504 Plan on the Grades 3–5 Mathematics and Science assessments. (See [Appendix C: Calculator Policy](#).)
- Confirm that enough Test Proctors are present for the test administration site.
  - Buildings may use Roving Proctors when simultaneous test sessions are occurring. The Roving Proctor must rotate through test sessions every 15–20 minutes and cannot be assigned to more than five testing sessions at any given time. The Roving Proctor’s duties include:
    - assisting Test Administrators
    - monitoring test sessions and escorting students
    - keeping the hallways quiet during testing
- Place a “TESTING: DO NOT DISTURB” sign on all doors to the testing location to minimize interruptions.

### **Before Start of Paper Testing:**

- Inventory test materials received from the BTC using the electronic Classroom Security Form.
- Complete the Classroom Security Form with *Student Name, Unique Test Booklet ID Number, and Form Number*. This form is provided to the TA by the BTC.
- Student labels should be applied to the appropriate answer documents. If you did not receive a student label, the student’s name, date of birth (DOB), Student Testing Number (STN), and demographic information must be bubbled on the answer document.
- Secure additional materials needed for testing (e.g., Number 2 pencils, scratch paper, and/or unmarked grid paper).
- Ensure all proper policies are followed for students who require special accommodations.
- Ensure electronic communication devices are not present while in the test administration site (e.g., cell phones, cameras, smartwatches, etc.).
- Ensure all desks are cleared and that each student has two sharpened Number 2 pencils with erasers.
- Calculators are only allowed as an approved accommodation for students on an IEP/504 Plan on the Grades 3–5 Mathematics and Science assessments. (See [Appendix C: Calculator Policy](#).)
- Confirm that enough Test Proctors are present for the test administration site.
  - Buildings may use Roving Proctors when simultaneous test sessions are occurring. The Roving Proctor must rotate through test sessions every 15–20 minutes and cannot be assigned to more than five testing sessions at any given time. The Roving Proctor’s duties include:
    - assisting Test Administrators
    - monitoring test sessions and escorting students
    - keeping the hallways quiet during testing
- Place a “TESTING: DO NOT DISTURB” sign on all doors to the testing location to minimize interruptions.

**During Online Testing:**

- TAs must remain in the testing session at all times to maintain and oversee security of tests. TPs/Roving Proctors must be actively observing testing sessions. If test items are being read aloud, a TA and TP are required in the room at all times to ensure test security.
- Ensure that students are able to log in to their scheduled test and that they understand how to navigate through the test.
- Notify the BTC of any technical issues as soon as they occur.
- Notify the BTC of any possible test invalidations, irregularities, or violations.
- Actively monitor students to ensure that students are working productively and maintaining test security.
- Record any observations in a log. A Test Proctor Observation Log sheet is available at the Cognia Oklahoma Help & Support Site on the forms page ([oklahoma.onlinehelp.cognia.org/forms](http://oklahoma.onlinehelp.cognia.org/forms)). Please be sure the TPOL is filled out completely.

**During Paper Testing (accommodations only):**

- TAs must remain in the testing session at all times to maintain and oversee security of tests.
- TPs/Roving Proctors must be actively observing testing sessions. If test items are being read aloud, a TA and TP are required in the room at all times to ensure test security.
- Notify the BTC of any possible test invalidations, irregularities, or violations.
- Actively monitor students to ensure that students are working productively and maintaining test security.
- Record any observations in a log. A Test Proctor Observation Log sheet is available at the Cognia Oklahoma Help & Support Site on the forms page ([oklahoma.onlinehelp.cognia.org/forms](http://oklahoma.onlinehelp.cognia.org/forms)). Please be sure the TPOL is filled out completely.

**After Online Testing:**

- Collect all test materials (login tickets, math reference sheets/writer's checklists if printed, and scratch paper and/or unmarked grid paper) from students after each testing session.
- Ensure that the calculator memory has been cleared. (See [Appendix C: Calculator Policy](#).)
- Move students who need additional time to the predetermined location according to your building's plan for providing additional time for unaccommodated students.
- Sign the electronic Test Administrator Test Security Form. Please see the instructions posted on the Cognia Oklahoma Help & Support Site ([oklahoma.onlinehelp.cognia.org](http://oklahoma.onlinehelp.cognia.org)).
- Return all test materials to your BTC.

**After Paper Testing:**

- Collect all test materials (booklets, answer documents, and scratch paper and/or unmarked grid paper) from students after each testing session.
- Ensure that the calculator memory has been cleared. (See [Appendix C: Calculator Policy](#).)
- Move students who need additional time to the predetermined location according to your building's plan for providing additional time for unaccommodated students.
- Sign the electronic Test Administrator Test Security Form. Please see the instructions posted on the Cognia Oklahoma Help & Support Site ([oklahoma.onlinehelp.cognia.org](http://oklahoma.onlinehelp.cognia.org)).
- Return all test materials to your BTC.
- Ensure students who are enrolled but do not participate in OSTP have a combined answer document returned for accountability purposes. The appropriate bubble(s) MUST be filled in on the back of each answer document.

## For Paper Testing:

### In the presence of a Test Proctor:

- Verify test booklet ID numbers to Student Names on the Classroom Security Form.
- Inspect each scorable answer document/test booklet to confirm:
  - it has a student label, or the demographic information is bubbled properly,
  - it has no stray marks that would hinder the machine scoring, and
  - it is in good condition, free of eraser bits, rough drafts, scratch paper or additional writing pages.
- Transcribe student responses from accommodated tests to standard scorable answer documents/test booklet and place the original student response in the inside front cover of scorable answer documents/test booklet.
- For Large-Print and Braille, the student responses must be transcribed into the standard scorable answer documents/test booklet provided in the kits. Return the original Large-Print and Braille test documents with the nonscorable materials.
- Count the number of used standard answer documents you are returning separately for each grade. As you count, arrange the answer documents so that the student name grids on the front covers are facing up. The booklets do not need to be alphabetized.
- Do not use paper clips, rubber bands, or any other fasteners that might damage the edges of the answer documents.
- Ensure that sticky notes were not placed on any scorable materials. If sticky notes were placed on an integrated test booklet or combined answer document, please remove them.

***This is extremely important since any damage will interfere with proper machine scanning.***

## Test Invalidations

Reasons for possible test invalidations include, but are not limited to:

- Cheating
- Security violation
- Testing outside the test window

## Test Irregularities

Reasons for possible test irregularities include, but are not limited to:

- Student requires redirection
- Technical problems
- Sudden illness
- Power failure

For a more detailed explanation of test invalidations and irregularities, please refer to [Appendix D](#).

Invalidations and irregularities must be immediately reported to the BTC.

# Responsibilities of the Test Proctor

The Test Proctor (TP) is an adult (18+) other than the Test Administrator (TA) who monitors the test administration. This adult must be approved by the building principal and can be a member of the faculty or community, but does not have to possess an Oklahoma Teaching Certificate. The TP cannot be a student and cannot be related to the Test Administrator or any student in the testing session. A TP is required for every testing session. **For an accommodated test session utilizing a human reader, the TP must be employed by the school district and remain in the room during the entire testing session.**

It is the responsibility of the DTC, BTCs, and TAs to inform TPs of their duties during the test administration. Prior to testing, the TA must confirm that enough TPs are present for the test administration site. The main job of the Test Proctor is to observe that testing procedures are followed and to report any potential invalidations, irregularities, or violations in testing to the TA and BTC. For online test administration sessions, one TP is required for 1–100 students. For online test administration sessions with more than 100 students, additional TPs are required.

Buildings may use Roving Proctors when simultaneous test sessions are occurring in lieu of using a TP for every testing session. The Roving Proctor must rotate through test sessions every 15–20 minutes and cannot be assigned to more than five testing sessions at any given time. The Roving Proctor's duties include assisting Test Administrators, monitoring test sessions and escorting students, and keeping the hallways quiet during testing. The Roving Proctor must always be available to TAs and to the BTC during testing. The Roving Proctor must meet the same training requirements and credentials as a TP.

## Before Day of Testing:

- Complete the online Test Administrator/Test Proctor Module with a minimum score of 80% on the quiz within the module and a completed attestation at the end of the module. Provide your BTC with a digital or printed copy of your training certificate.
  - **Note: Training modules are available in Canvas on the Cognia Oklahoma Help & Support Site: [oklahoma.onlinehelp.cognia.org](http://oklahoma.onlinehelp.cognia.org).**
- Review Test Security and Validity Rules at [rules.ok.gov/code](http://rules.ok.gov/code). Oklahoma Administrative Code 210:10-13-4

## Before Start of Testing:

- Arrive at least fifteen minutes before the first test is administered.
- Observe that all posters and visual aids have been covered or removed within the testing site.
- Ensure electronic communication devices are not present while in the test administration site (e.g., cell phones, cameras, smartwatches, etc.).
- Ensure all desks are cleared and that each student has pencils with erasers.
- Assist in maintaining the security of all test materials.

## During Testing:

- TPs and Roving Proctors may help with distributing test materials to students under the guidance of the TA.
- Observe that the directions have been read from a script provided in this *Test Administration Manual*.
  - **NOTE:** All directions are to be given at the **beginning** of the session for each test. Students are allowed to ask questions **after** directions are given and **before** the signal is given for students to begin. Such questions are allowed to ensure that clarification of test directions is accomplished.
- Closely monitor the test administration and record observations in a log. A Test Proctor Observation Log sheet is available at the Cognia Oklahoma Help & Support Site on the forms page ([oklahoma.onlinehelp.cognia.org/forms](http://oklahoma.onlinehelp.cognia.org/forms)). Please be sure the TPOL is filled out completely.
- If test irregularities occur, the TP or Roving Proctor should inform the TA as silently and unobtrusively as possible. In addition, the proctors may assist the TA with finding solutions as needed. Such irregularities may include, but are not limited to, the following examples:
  - marking answers without reading test questions
  - talking to another student (or other similarly distracting behaviors)

- becoming ill and having to leave the room
  - testing environment disruptions (e.g., technical issues, fire/tornado alarm sounded, loss of power)
- ❑ Looking at another student’s test booklet/answer document or computer screen is a violation of test security regulations.
- This is an example of cheating and would result in invalidation. See Appendix D for details.
- Appendix D contains a list of possible student actions/Test Administrator actions. These student actions are to be used as examples and should not be considered an exhaustive list.
- ❑ TAs and TPs must remain in the testing session at all times to maintain and oversee security of tests by:
- Ensuring that **no person** reads or views the contents of a test at any time except the student taking the test at the time of testing.
  - Verifying that test materials are locked in a storage area at all times when not in use for official test administration purposes.
  - Reporting breaches of test security regulations to the TA and the BTC.
- ❑ The TP is to refrain from talking to the TA and/or students once the test session has begun. During this time, it is preferable that the TP sit quietly and observe as unobtrusively as possible.

**After Testing:**

- ❑ Help collect and organize test materials for return to the BTC.
- ❑ Report any unusual circumstances or breaches of test security regulations to the TA, BTC, and/or the building principal.
- ❑ Observe and assist TA checking test booklets for random marks.
- ❑ Observe TA transcribe responses from accommodated tests to standard scorable documents/test booklets.
- ❑ Test Proctors must complete and sign the Test Proctor Observation Log. Please note that the Test Proctor Observation Log includes a Nondisclosure Agreement. A TP should complete at least one row for every test session proctored. The columns in each row must also be completed.

# OSTP Testing Schedule

## Testing Schedule Information

**UNDER NO CIRCUMSTANCES SHOULD YOU BEGIN A TEST UNLESS THERE IS ENOUGH TIME TO COMPLETE IT.** The following tables list approximate times required to complete each section of the assessments. These approximations are to be used solely for scheduling purposes.

Students who have not finished at the end of the scheduled testing session should be given additional time. This time must be given as an immediate extension of the current testing session; it is not available as a separate session or at another time. It is highly recommended to only extend the testing session by double the maximum times recommended in the tables.

All test sections **MUST** be administered in sequential order with the exception of Grade 5 English Language Arts Writing prompt. The Writing prompt can be administered at any time during the testing window. **Students who are absent during testing must still test in sequential order during a make-up session upon their return.** Mixed group testing is allowed for make-up sessions.

Students who finish early may be dismissed from the session or may read or sit quietly until the end of the test session.

Paper versions of the test are available for those students with appropriate accommodations and will follow the same time estimates.

# Online Testing

## Before Online Testing

### Reading Directions Aloud

Read aloud the **bold type** material that is preceded by the word “Say.” *Italicized* material is information for the TA that should not be read aloud to the students.

Read the directions to the students exactly as they are written, using a natural tone and manner. If you make a mistake while reading, stop and say, “No, that is wrong. Listen again.” Then read the directions again. **Never deviate from the directions as written. Deviating in any way from the printed directions is a testing violation.**

As a Test Administrator (TA) for online tests, you are required to follow the same security procedures as when administering paper tests.

### Ensure You Have the Required Test Materials

## During Online Testing

Make sure that a Test Proctor/Roving Proctor is actively monitoring before beginning the directions for the assessment; Test Proctors/Roving Proctors must be actively observing the entire testing session. If test items are being read aloud, a TA and TP are required in the room at all times to ensure test security.

To ensure a standardized administration that produces accurate achievement results, all Test Administrators must follow the same steps when administering the tests. Begin a testing session only once all students are present.

Sample Questions have been standardized by grade span within each content area to allow for mixed grouping. Students may be combined by grade spans for test administration of a single content. For example, students in grades 3–5 taking the Mathematics Assessment can be grouped into one location. The approved grade span groupings are 3–5. The English Language Arts Writing prompt for Grade 5 should be given at a separate time.

Be sure students understand the directions, how to mark answers, and the use of tools.

If a student must leave the room for a short period during the test session, the student should click on the Pause/Exit button, which appears at the bottom of each screen. The student will have 20 minutes to resume his or her test. If the time exceeds 20 minutes while paused, or no student activity is detected for 60 minutes during the test, the student will be unable to get back into the test, and a Proctor Password will be required to re-access the test. Only the DTC has access to the Proctor Password. The TA must contact either the BTC or DTC to obtain the Proctor Password. Any questions the student has viewed will be locked, and the student will not be able to return to those questions.

**Note: The Proctor Password is considered secure material and may only be entered by the TA, BTC, or DTC. The password should never be shared with students.**

**Note: During testing, only one student at a time should be allowed to leave the room. While in “Pause” mode, students should not visit with other students, go to their lockers unassisted, have food or snacks brought to them, or take a lunch break.**

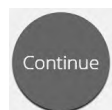

Clicking the “Next” button will take you to the next question. Click the “Next” button now.**

**Now you will see that the “Back” button can be used. Clicking the “Back” button will take you to the previous question. Click the “Back” button now.**



**The star located in the upper left of the screen will allow you to bookmark any question you would like to review later. Click on this star now.**

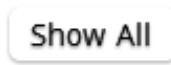
**Another way to move through the test is by using the Test Map. You can find the Test Map by clicking on the down-arrow next to the question number at the top left of the screen. Click this arrow now.**

**The Test Map shows all of the questions on the test. Answered questions will appear blue, questions you have viewed but not answered are red, questions you have marked for review will have a yellow star next to them, questions that have not been visited are gray. Notice that question A is marked with a star. Clicking on a question number will take you directly to that question on the test. You can also pause or return to the test from the Test Map.**

Say: Click on “A.” You are now back to Sample Question A. Click on the star to remove the mark.



Look at the four options in this question. Next to each letter is a drawing that looks like an eye. Clicking on this “eye” will hide the option. Clicking again will make it reappear. You can use this tool if you are unsure of an answer but would like to hide the options you know are not correct.



You can also use the “Hide All” or “Show All” button above the options to hide all options or show all options if some have been hidden.

Your toolbox is in the bottom left corner of the screen. You will see several tools available to use on this test.



The guideline tool provides a small window you can move up or down the page to cover some of the words to help you with reading. The “white” space can be resized by dragging the bottom right corner.



The sketch tool will open a highlighter, several colored pencils, and an eraser. Use this tool to highlight parts of the text or question you want to stand out. Click on this tool now. When you click it, a selection box will appear.



Click on the yellow highlighter in the sketch tool. The sketch highlighter tool is a freehand highlighter that can be used to circle, underline, or mark through text. Click on this tool and highlight a word in the question. Now click on the blue pencil and circle a word in the question. You can erase the marks you just made by clicking on the eraser and then clicking on the mark. Click the “X” in the upper right corner of the box to close the sketch tool.



The highlighter tool can be used to highlight specific lines of text within a passage or question. When you click the highlighter tool, a selection box will appear.



Click on the yellow highlighter from the box and highlight a word in the passage or question. You can erase the highlight made by clicking on the eraser and selecting the word to erase the highlight. To clear all highlighting on the screen click “Clear All.” Click the “X” in the upper right corner of the box to close the highlighter tool.

### Grades 3–5 English Language Arts Directions with Sample Questions

Say: The English Language Arts Online Test screen is divided in half with a line going down the middle of the screen. The reading passages will appear on the left side of the screen, and the questions you have to answer will appear on the right side. You will see a scroll bar that you may have to use to view all of the reading passage text.

As you take the English Language Arts Online Test, you may find you have been asked to read part of a passage you have read previously, either in class or on your own. When you answer the questions that follow the passage, it is important that your answer be based solely on the part of the passage that appears on this test.

## General Directions (continued)

Say: **This completes the sample questions.**

**Follow the directions that appear throughout the test and read and answer each question. If you are not sure about an answer, you may use the star tool to mark the question for later review. Remember that questions left unanswered are scored as incorrect.**

**When you come to the last question in this section, you will see the “Finish” button on the bottom right of the screen. Once you have answered the last question in this section, click the “Finish” button to submit the test. You will be taken to the Summary Page.**

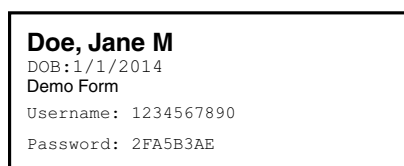

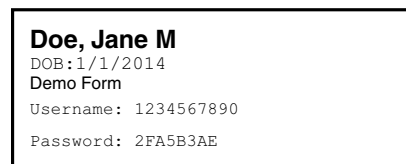

**When scorers evaluate your writing, they will look for evidence that you can:**

- **address the prompt;**
- **develop your ideas thoroughly;**
- **organize your ideas;**
- **stay focused on your purpose for writing;**
- **make your writing thoughtful and interesting; and**
- **use correct spelling, capitalization, punctuation, grammar, usage, and sentence structure.**

**DO NOT CLICK THE “TURN IN” BUTTON until you are completely finished with your writing. Once you click “Turn In,” you will NOT be able to return to your response.**

**Are there any questions on the directions?**

*Pause; answer any questions students may have.*

Say: Use the information to answer the following question.

Read the sample to yourself as I read it out loud.

The drawing shows some plants and animals that live in the Black Kettle National Grassland in southwestern Oklahoma.

Some students wanted to make a model to show how matter moves through this grassland. The students had learned that the movement of matter allows plants and animals in the grassland to get nutrients or food. If the plants and animals do not get the nutrients or food they need, they cannot survive.

By making the model, the students could predict how well plants and animals would survive if events such as fire or drought happened in the ecosystem.

Now look at Sample Question A.

Read the sample to yourself as I read it aloud.

What can the students add to their model to show that matter also moves between organisms and the environment?

(A) rocks, because they are a common part of soil, (B) Sun, because it allows plants to make their own food, (C) wind, because it carries air and dust around the grassland, (D) decomposers, because they break down dead plants and animals.

Click on the correct answer. *(Pause for replies.)*

Say: The correct answer is “(D) decomposers, because they break down dead plants and animals.” If you want to change your answer, simply click on another answer choice. Now, try using the tools to ensure you are comfortable using them. *(Give students time to use the tools.)*

Say: You must answer this question before moving forward. Click on the Next button in the bottom right corner of your screen.

Now look at Sample Question B. Read the sample to yourself as I read it aloud.

Which set of events should the students’ model also include to show how matter moves in the ecosystem?

(A) Plants take up air and water to make food. → Animals eat plants. → Animals breathe out air. (B) Plants release food as waste. → Animals break down wastes from plants. → Animals breathe out air. (C) Animals take in air and water to make food. → Other animals eat these animals. → Animals release waste. (D) Animals release water into air. → Water is taken up by animals to make food. → Other animals eat these animals.

Click on the correct answer. *(Pause for replies.)*

Say: The correct answer is “(A) Plants take up air and water to make food. → Animals eat plants. → Animals breathe out air.” If you want to change your answer, click on another answer choice.

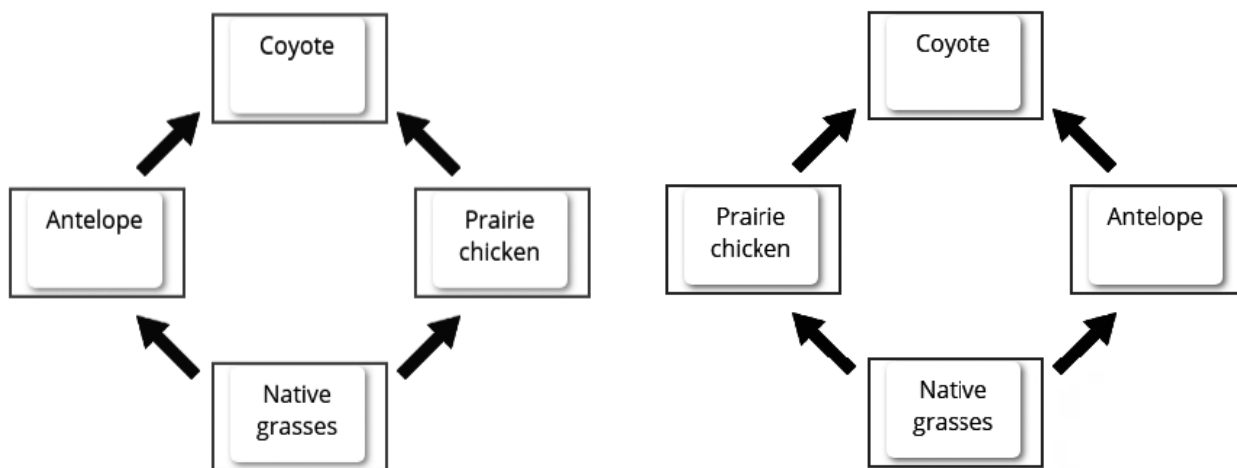
## Sample Questions for Grade 5 Science (continued)

Say: Now look at Sample Question C. Read the sample to yourself as I read it aloud.

The students also learned what some of the organisms eat. Prairie chickens eat native grasses and coyotes eat prairie chickens. Native grasses are eaten by antelope and antelope are eaten by coyotes.

Drag the organisms into the food web to show how matter moves among the organisms. To drag an organism, click and hold the organism, and then drag it to the desired space. To change an organism, click and hold it, and then drag it back to the original location.

Study the words in the boxes. Follow the instructions to arrange the words in the correct spaces. During the test, when answering questions like this, make sure you fill all spaces with an answer to receive full credit. (Pause for replies. The correct answer is shown below.)



Say: The box on top says coyote. The boxes on the left and right say antelope and prairie chicken. The box on the bottom says native grasses.

Are there any questions? (Answer all questions about how to click on the correct answer, but do not give students content instruction.)

## Use the Classroom Security Form to Assign Test Booklet ID Numbers to Students

Write the name of the student along with the assigned test booklet ID and form number of each standard, Large-Print, and Braille test booklet on the Classroom Security Form. Make a copy of the Classroom Security Form after testing and return with your testing materials to the BTC.

## Reading Directions Aloud

Read aloud the **bold type** material that is preceded by the word “Say.” *Italicized* material is information for the TA that should not be read aloud to the students.

Read the directions to the students exactly as they are written, using a natural tone and manner. If you make a mistake while reading, stop and say, “No, that is wrong. Listen again.” Then read the directions again. **Never deviate from the directions as written. Deviating in any way from the printed directions is a testing violation.**

## During Paper Testing

Make sure that a Test Proctor/Roving Proctor is present before beginning the directions for the assessment; Test Proctors/Roving Proctors must be actively observing the entire testing session. If test items are being read aloud, a TA and TP are required in the room at all times to ensure test security.

To ensure a standardized administration that produces accurate achievement results, all Test Administrators must follow the same steps when administering the tests. Begin a testing session only once all students are present.

Sample Questions have been standardized by grade span and content area to allow for mixed-grouping administrations. Students may be combined by grade spans for test administration of a single content. For example, students in grades 4 and 5 taking the Mathematics Assessment can be grouped into one location. The English Language Arts Writing prompt for Grade 5 should be given at a separate time.

Be sure students understand the directions and how to respond. Assist them with test-taking mechanics, but be careful not to inadvertently give hints or clues that indicate an answer or help eliminate answer choices. Remind students to handle all materials with care and to avoid making extra marks. The test booklets/combined answer documents should never be folded, clipped, or torn.

If a student must leave the room for a short period during the test session, the student should turn his or her test booklet over and place the answer document under the test booklet on the desk.

**Note: During testing, only one student at a time should be allowed to leave the room. Students should not visit with other students, go to their lockers unassisted, have food or snacks brought to them, or take a lunch break.**

Post the teacher’s name, school name, district name, county name, and today’s date for students to copy.

**All students must use the name of their official school of enrollment.** Lead students through filling in lines A–D on the front of their combined answer document with the “For All Students” directions. If students do not have a label, continue reading the “For All Students Without Labels” directions. The demographic page will need to be filled out on the back of the combined answer document if no label is present.

**If you are administering grade 3, students will answer the questions directly in the test booklet. There is not a separate answer document for grade 3.**

Say: **Slide the end of your pencil under the seal and open your test booklet to page 2.**

*Read for non-Large-Print: Find the question number in the answer document that matches the question number in the test booklet. Then mark your answer in the answer document.*

*Read for Large-Print: Then circle the letter of the correct answer in the test booklet.*

**Use the information to answer the following questions.**

**The drawing shows some plants and animals that live in the Black Kettle National Grassland in southwestern Oklahoma.**

**Some students wanted to make a model to show how matter moves through this grassland. The students had learned that the movement of matter allows plants and animals in the grassland to get nutrients or food. If the plants and animals do not get the nutrients or food they need, they cannot survive.**

**By making the model, the students could predict how well plants and animals would survive if events such as fire or drought happened in the ecosystem.**

**Now look at Sample Question A. (Point to Sample Question A.)**

Say: **Read the sample to yourself as I read it aloud.**

**What can the students add to their model to show that matter also moves between organisms and the environment?**

*Read for Large-Print: Circle the letter “D” in your test booklet. (Pause)*

**Now look at Sample Question B. Read the sample to yourself as I read it aloud.**

**Which set of events should the students’ model also include to show how matter moves in the ecosystem?**

**(A) Plants take up air and water to make food. → Animals eat plants. → Animals breathe out air. (B) Plants release food as waste. → Animals break down wastes from plants. → Animals breathe out air. (C) Animals take in air and water to make food. → Other animals eat these animals. → Animals release waste. (D) Animals release water into air. → Water is taken up by animals to make food. → Other animals eat these animals.**

*Read for non-Large-Print: Mark your answer in the answer document. Be sure to fill in the circle completely and make your mark heavy and dark. If you want to change an answer, completely erase the mark you made before making a new mark. Do not turn the page until I tell you to do so.*

*Read for Large-Print: Circle your answer in your test booklet. If you want to change an answer, completely erase the mark you made before making a new mark. Do not turn the page until I tell you to do so.*

Say: **Which is the correct answer?** (*Pause for replies.*)

Say: **You should have filled in “(A) Plants take up air and water to make food. → Animals eat plants. → Animals breathe out air.”**

Say: **Are there any questions?** (*Answer all questions about how to mark the answer, but do not give students content instruction.*)

## General Directions (continued)

Say: **Turn to the next page of the test booklet.**

**This page begins the Science Test. As you are taking the Science Test, sometimes there will be a chart, a table, or a graph that you will have to look at carefully to answer a question.**

**You may underline, make notes, or work problems in your test booklet, or use the scratch paper that is provided,**

*Read for non-Large-Print: but be sure to mark all your answers in the combined answer document.*

*Read for Large-Print: but be sure to circle all your answers in the test booklet.*

Say: **Answer all of the questions on this page and the pages that follow until you come to the end of the section, where you will see the word STOP.**

**If you finish this section early, you may go back and check your work in this section only. Do not go on to the next section. **Are there any questions?** (*Answer all questions related to completing the test, but do not give students content instruction.*)

**Remember to choose the best answer for each question. If you are not sure about an answer, do the best you can, but don't spend too much time on any one question.**

**You may now begin.**

*While students are working, walk around the room to see that they are following directions and that they are not looking at another student's test. Do not give help with reading any part of the test.*

*If, at the end of the approximate testing time, you notice that any students need more time, have them continue in the room or another room with a Test Administrator and Test Proctor present.*

*When testing has completed, collect all test booklets, answer documents, and scratch paper before students leave.*

*For Large-Print or Braille tests to be scored, a Test Administrator must transcribe the student responses into a regular test booklet using a Number 2 pencil while in the presence of a Test Proctor. Please see [Appendix B](#) for directions for transcribing.*

## Directions when continuing on to the next section immediately

If students are continuing to the next section immediately following this section, there is no need to review directions again. Have the students open their test booklets and answer documents to the next section and begin.

*After the suggested time or when all students have completed the test, collect the test booklets and combined answer documents from all students. Also collect the scratch and/or unmarked grid paper and turn it in to the Building Test Coordinator to be destroyed.*

*Any students who have not completed the test should be given additional time. These students may be relocated to another testing environment and allowed to continue under the supervision of a Test Administrator and Test Proctor.*

*If a student took a Large-Print or Braille test, follow the instructions in [Appendix B](#) for transcribing the student's answers to a regular test booklet.*

## Directions when completing next section in a separate session (same day or consecutive days)

**DO NOT BEGIN TESTING UNLESS A TEST PROCTOR IS PRESENT.** *Be sure that desks are cleared and see that each student has two sharpened Number 2 pencils, an eraser, and scratch paper and/or unmarked grid paper. Mechanical pencils are not allowed. All scratch paper should be collected before students leave the testing session.*

**Provide today's date.**

Say: *(While passing out materials)* **Do not open your materials until I tell you what to do.** *(Distribute the materials. Check to see that each student gets the right test booklet.)*

Say: **Make sure your name is on the test booklet and answer document you received. If it is not, please raise your hand.** *(Pause)*

*(Continue once you have confirmed everyone has the correct materials.)*

Say: **Today you will take Section 2 of the Science Test. It is important that you do your best on this test. You have been given a test booklet, answer document and test materials. Only use the scratch paper that has been provided. Your test materials, including your test booklet and answer document, will be collected at the end of this testing session.**

**Cell phones or other electronic devices, including smartwatches, must not be present in the testing environment. The use of reference materials, dictionaries, cell phones, electronic devices, or additional material or equipment is not allowed on this test.**

**Open your Test Booklet to Section 2.** *(Make sure students are on the correct page to begin Section 2.)*

Say: **Answer all of the questions on this page and the pages that follow until you come to the end of the test, where you will see the word STOP.**

**If you are not finished with the test at the end of the test session, you may be given additional time.**

**Remember to choose the best answer for each question. If you are not sure about an answer, do the best you can, but don't spend too much time on any one question.**

**If you finish early, you may check your work in this section only. Do not go back to a previous section.**

**When you have finished, put your pencil down. Close your test booklet and answer document so that the front covers are on top. You may read or sit quietly until everyone has completed the test.**

**You may now begin.**

*While students are working, walk around the room to see that they are following directions and that they are not looking at another student's test. Do not give help with any part of the test.*

*If, at the end of the approximate testing time, you notice that any students need more time, have them continue in the room or another room with a Test Administrator and Test Proctor present.*

*When testing has completed, collect all test booklets, answer documents, scratch paper, and/or unmarked grid paper before students leave. Return these to the Building Test Coordinator.*

## Complete and Sign All Test Security Forms

All Security forms will be completed and submitted electronically. Please see the instructions posted on the Cognia Oklahoma Help & Support Site on the forms page ([oklahoma.onlinehelp.cognia.org/forms](http://oklahoma.onlinehelp.cognia.org/forms)) to complete the tasks listed below.

- Complete and submit the Electronic Test Administrator Security Form, assuring that security has been maintained and test procedures have been followed.
- A Nondisclosure Agreement (NDA) is incorporated into the Test Administrator Security Form. Test staff are not allowed to divulge the contents of the test, generally or specifically to anyone, nor copy any part of the test.
- Security form submission evidence and training completion evidence must be retained in a paper or digital format at the district level for at least 5 years.

## Return All Test Materials

Return all test materials to your Building Test Coordinator at the close of testing every day.

# Appendix A: Special Situations

---

## Student Absent

- Students who are absent on the scheduled testing date for their grade for any reason **MUST** be administered a closely monitored make-up test the day they return to school. Make-up tests may be administered any time after the scheduled testing date and before the end of the test administration window. Make-up tests **MUST** be administered in sequential order with the exception of Grade 5 English Language Arts, for which the writing prompt can be administered at any time during the testing window.

## Student Becomes Sick During Testing

- If a student becomes ill during a test and is unable to complete the session, he or she must be scheduled for a closely monitored make-up session to complete only the questions not yet answered. Students may not change answers or review responses to any questions that they viewed prior to leaving the test space.

## Damaged Test Booklet

- If a test booklet needs to be replaced due to damage (ripped, torn, or biohazard) contact the DTC for a replacement test booklet and provide the following information:
  - Reason for the replacement
  - Content area and form number of the test booklet
  - Student’s full name and Student Testing Number (STN)
  - Test Booklet identification number located in the bottom left corner of the test booklet

## Contaminated Materials

- If any test materials become contaminated, the following procedures **must** be followed:
  - **Test Booklets:**
    1. Obtain the test booklet number located on the front bottom left corner of the test booklet below the barcode.
    2. Indicate the test booklet number on the Security Checklist as contaminated.
    3. Call the Cognia Oklahoma Service Desk and provide them with the test booklet number and reason for the contamination (e.g., bodily fluids).
    4. Discard the test booklet following the protocol set by your State Department for the disposal of hazardous materials. ***Do Not Return to Cognia.***
  - **Combined Answer Documents:**
    1. Obtain the answer document number located on the front bottom right corner of the answer document.
    2. Indicate the answer document number on the Security Checklist as contaminated.
    3. If a student completed any work in an answer document, his or her work must be transcribed into a replacement answer document.
    4. Indicate the replacement answer document number on the Security Checklist.
    5. Discard the answer document following the protocol set by your State Department for the disposal of hazardous materials. ***Do Not Return to Cognia.***

# Appendix B: Transcription of Student Test

---

## Transcribe Combined Answer Documents for Students Taking Large-Print or Braille Versions of the Test

After testing, the Test Administrator should prepare the standard combined answer document that was provided in the Large-Print or Braille kit for each student taking the Large-Print or Braille version of the test. First, apply the student's label to the standard combined answer document. If the student does not have a student label, follow the directions on page 38 of this manual. (For students taking the contracted Braille version, remember to fill in the IEP Braille circle in Box E.) Then transfer the student's test answers from the Large-Print or Braille test booklet to the standard combined answer document.

The standard combined answer documents for the Large-Print and Braille tests should then be included with the other student combined answer documents. The original Large-Print and Braille test booklets and combined answer documents should be returned with the nonscorable test materials.

## Transcribe Combined Answer Documents for Accommodated Responses

### Test Administrators are responsible for:

- maintaining the security of all computers used by students who receive an accommodation;
- ensuring that students do not have access to the Internet or any files on the computer hard drive or network during testing, as results may be invalidated for students who access the Internet or files during testing;
- ensuring that no response is edited by anyone other than the student, and the response is done only during the test-taking period;
- deleting all student responses that were temporarily saved on any local computer after all student responses have been printed for submission with an answer document. **Student responses are secure and confidential and must not be accessible to unauthorized individuals.**

### Information Required for Each Page

You must provide the following information on each page of each student's response. The required information listed below must be handwritten or typed on each page.

- Student Name
- Student Testing Number (STN)
- Answer document serial number (the 10-digit number located on the lower right corner)
- Subject
- Question number
- For the ELA Writing Prompt only, page x of y, where x = the current page number and y = the last page number

### Formatting Requirements

#### Formatting:

- Use plain white paper (8 ½" x 11").
- Use a font size between 8-point (minimum) and 12-point (maximum).
- Set margins to be one inch.
- Set line-spacing to be single-spaced.

#### Page limits:

#### For responses to open-response and short-answer questions:

- Submit a separate page for each open-response or short-answer question.
- A maximum of one page may be submitted for each response.

#### For the ELA Writing Prompt:

- A maximum of four pages may be submitted.

The typed response pages must be placed inside the front cover of the student's standard answer document without clips, tape, or staples. All information requested on the front cover and back cover of the student's answer document must be properly completed by the Test Administrator and Test Proctor.

# Appendix C: Calculator Policy

## OSTP Calculator Policy

Oklahoma School Testing Program (OSTP)

### Purpose

The items on the Grades 6-8 Math, Grade 8 Science, and CCRA Science content assessments are designed so that all tasks can be solved without the use of a calculator. However, certain tasks are more difficult if a calculator is not available.

Before the first day of the test, students using a calculator for any Math and Science assessment should be familiar with the use of the specific calculator that can be utilized. Students should be consistently instructed throughout the school year in the use of calculators; otherwise, it may hinder students' performance on the assessment.

### Grade Specific Requirements

#### Grades 3-5 Math

- Calculators are **only** allowed as an approved accommodation for students on an IEP or 504 Plan. Only Basic Four-Function calculators as described below are allowed.

#### Grades 6-7 Math

- Basic Four-Function calculators with square root, +/-, and percent buttons are allowed. Calculators with memory keys, including M+ and M-, are also acceptable.

#### Grade 8 Math and Science

- Scientific calculators meeting the general requirements listed below are allowed.

#### Grade 11 CCRA Math and Science

- Math: Please see the calculator policy of the ACT assessment.
- Science: Graphing and/or Scientific calculators meeting the general requirements listed below are allowed.

### General Requirements

- Calculators are permitted but are not required.
- Calculator capabilities described for a specific subject give the maximum capabilities allowed; calculators with less capability are acceptable.
- Students may not share calculators.
- Students may use their own calculators or those provided by the school.
- Programs, applications, or documents must be removed or disabled prior to the test session.
- **All calculators must have the memory cleared or reset before and after the test session.**
- See the manufacturer website or user guide for clearing procedures.

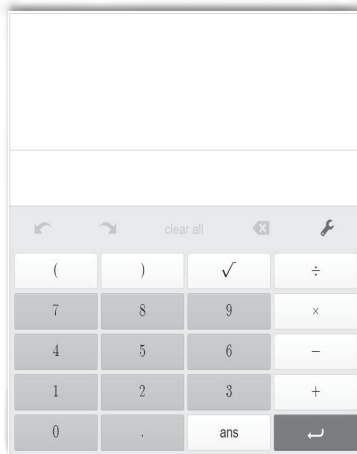

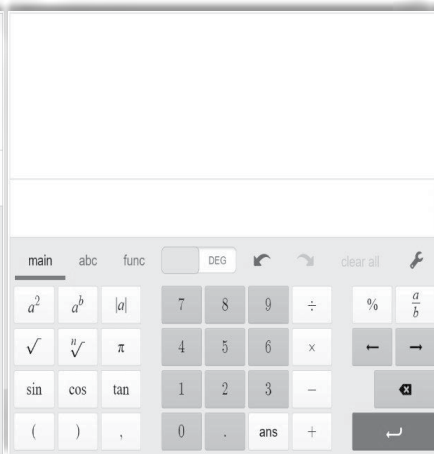

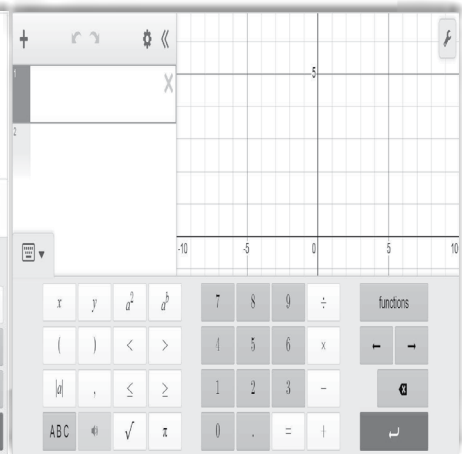

# Appendix D: Student/Test Administrator Actions

**Shown below are some possible student/Test Administrator actions that could occur during testing.**

These student actions are intended to be used as examples and should not be considered an exhaustive list.

**Note:** In order to minimize wait time, only DTCs should contact the SDE.

All irregularities should be reported to OSDE via the Irregularity Google Form. All invalidations should be submitted on the Accountability Reporting Application in Single Sign-On. All irregularities AND invalidations should be noted on the Test Proctor Observation Log (TPOL).

The student's test has timed out.	The TA will contact the BTC/DTC to obtain the Proctor Password. ONLY the TA, BTC, or DTC may enter the Proctor Password. Under no circumstances should the Proctor Password be given to a student or posted on a board.	Irregularity
