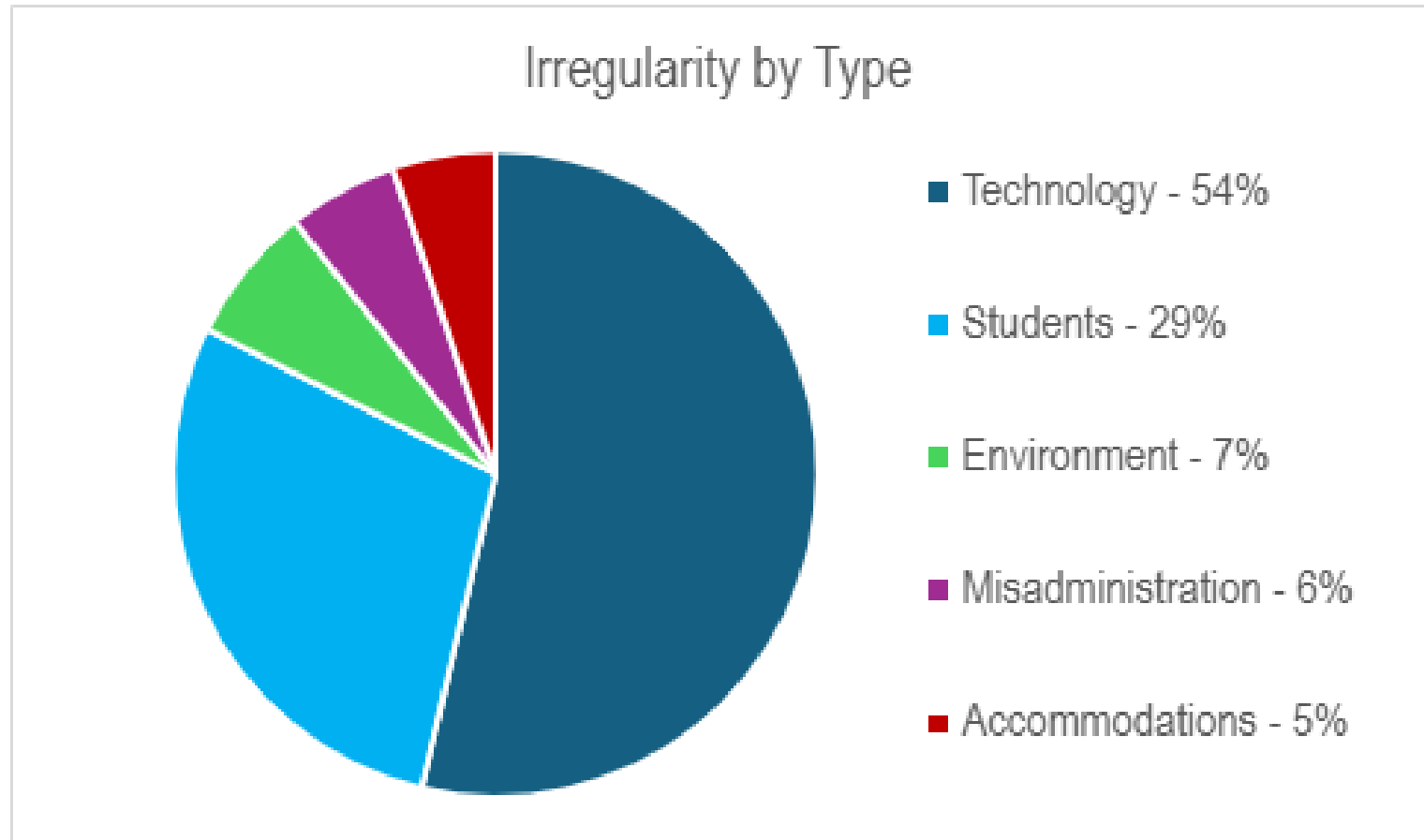

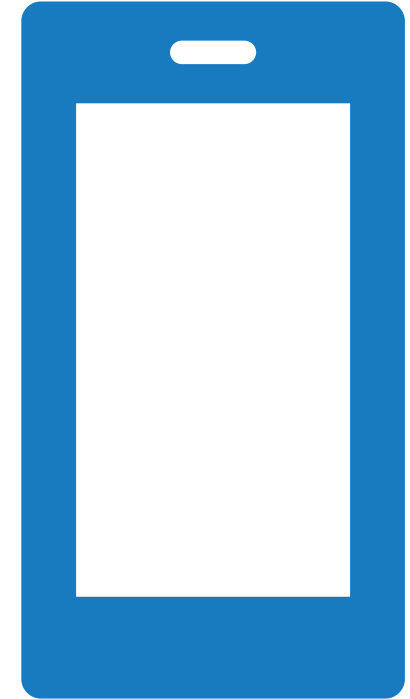

Invalidations

- Accommodation issues
- Cell Phone Usage
- TA/TP behavior
- Technology issues



Troubleshooting

- Many students did not have the proper embedded accommodations marked BEFORE enrolling them into a test session.
- Once you move them into a testing session, a test form is assigned to them automatically. If you click the accommodation button after moving them into the testing session, it is too late as their test form was already assigned.

Troubleshooting (continued)

- Missed deadlines:
 - ACT Accommodations Request is due in **late January/early February**. We communicate this out in Gov Deliveries and on our update webinars. ACT also sends out emails and does a targeted Accommodation webinar.
 - Non-Standard Accommodation window to submit applications always runs from **December 1 – February 1**.
 - Testing windows are different for CCRA, ACT, and OSTP 3-8.
 - These are always listed on our assessment calendar posted on our [home page](#).
 - This calendar is posted in August. If any changes are made, we send out Gov Deliveries about it, as well as mention it in our webinars.

ELP Band Exit

What is ELP Band Exit?

- The ELP Band Exit is an alternate path for exiting EL services for qualifying English Learners who did not auto exit. The ELP Band Exit window occurs in August.
- The ELP Band Exit submission window is tentatively scheduled for **August 1-30, 2025**.
- ELP Band Exit will be subject to monitoring and corrective action if not implemented in a standardized manner.

What is the ELP Band Exit for the ACCESS?

Grade 3-8 Auto ELP Band Exit

- ALL grades 3-8 students scoring between the **4.3-4.7** range on the ACCESS and scoring Proficient or above on the OSTP ELA assessment **will be automatically band exited**. Nothing will be required from the LEA.

What is the ELP Band Exit for the ACCESS?

Grade 9-12 ELP Band Exit

- For ALL qualifying students in grades 9-12 scoring between the **4.3-4.7** range on the ACCESS and at or above the 35th percentile on state approved assessments, **ALL LEAs will be required to upload qualifying score sheets indicating reading percentiles into Student Assessment ELP Band Exit Request DVRs in Accountability Reporting.**

What is the ELP Band Exit for Alternate ACCESS?

Grade 3-8 & 11 Auto ELP Band Exit

- ALL 3-8 and 11 grade students scoring a **3.0** on the Alternate ACCESS and scoring Basic or above on the OAAP ELA assessment **will be automatically band exited**. Nothing will be required from the LEA.

What is the ELP Band Exit for Alternate ACCESS?

Grade 9, 10, & 12 ELP Band Exit

- For **ALL** qualifying students in grades 9, 10, and 12 scoring a **3.0** on the Alternate ACCESS, **ALL LEAs will be required to complete an Alternate ACCESS ELP Band Exit Recommendation Form** because there is no state assessment to qualify students in grades 9, 10, and 12.
- The LEA only needs to submit the completed **Alternate ACCESS ELP Band Exit Recommendation Form** into a Student Assessment ELP Band Exit Request DVR in Accountability Reporting on Single Sign On **if the student has been recommended to band exit**. If the student is not recommended to band exit, the form is to be kept at the local level.

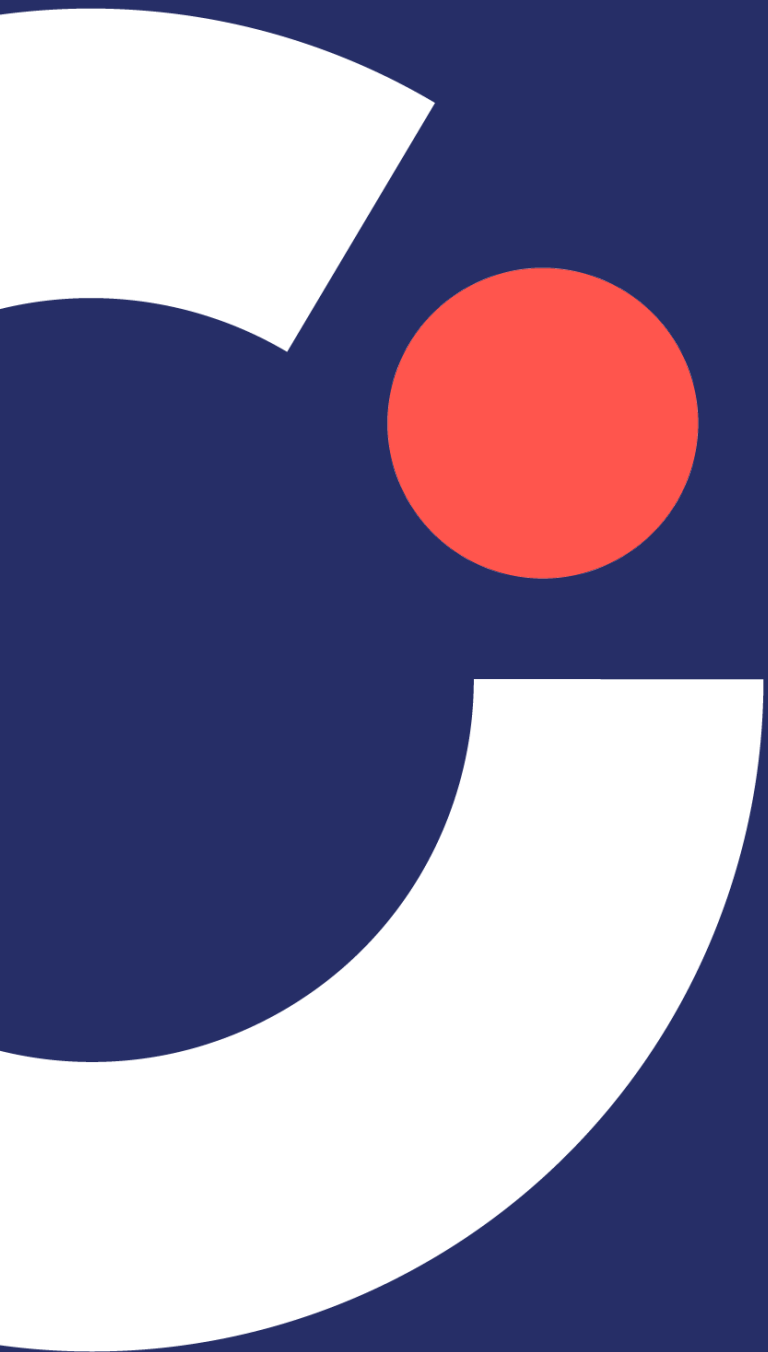

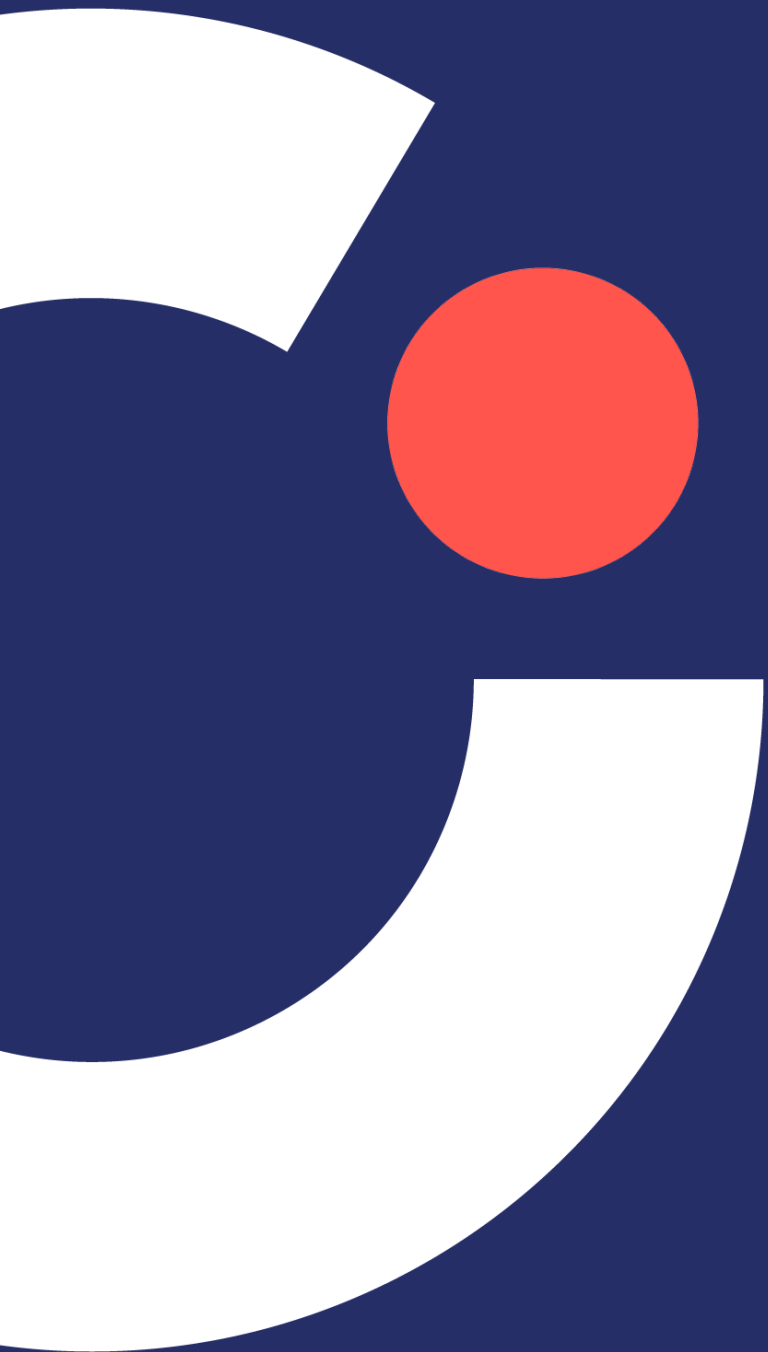

New Features Implemented for Spring 2025

- Standardized Text-to-Speech (TTS) voice across all operating systems using Cloud TTS.
 - A Cepstral voice pack for Spanish TTS was not needed.
- Remote proctoring to administer state assessments virtually to students in grades 3 through 8.

Changes for Reporting Spring 2025

- Educator Portal
 - Removal of Grade 3 Early RSA score
 - New field added to indicate if remote proctoring was enabled for the student
 - The field is added to Roster level reports
 - Summary level reports and data tools will be available for final release but not for preliminary release
- Parent Portal
 - Removal of Grade 3 Early RSA score
 - New Ways to Support text for ELA, Math, and Science
 - Summary level data will be available for final release but not for preliminary release

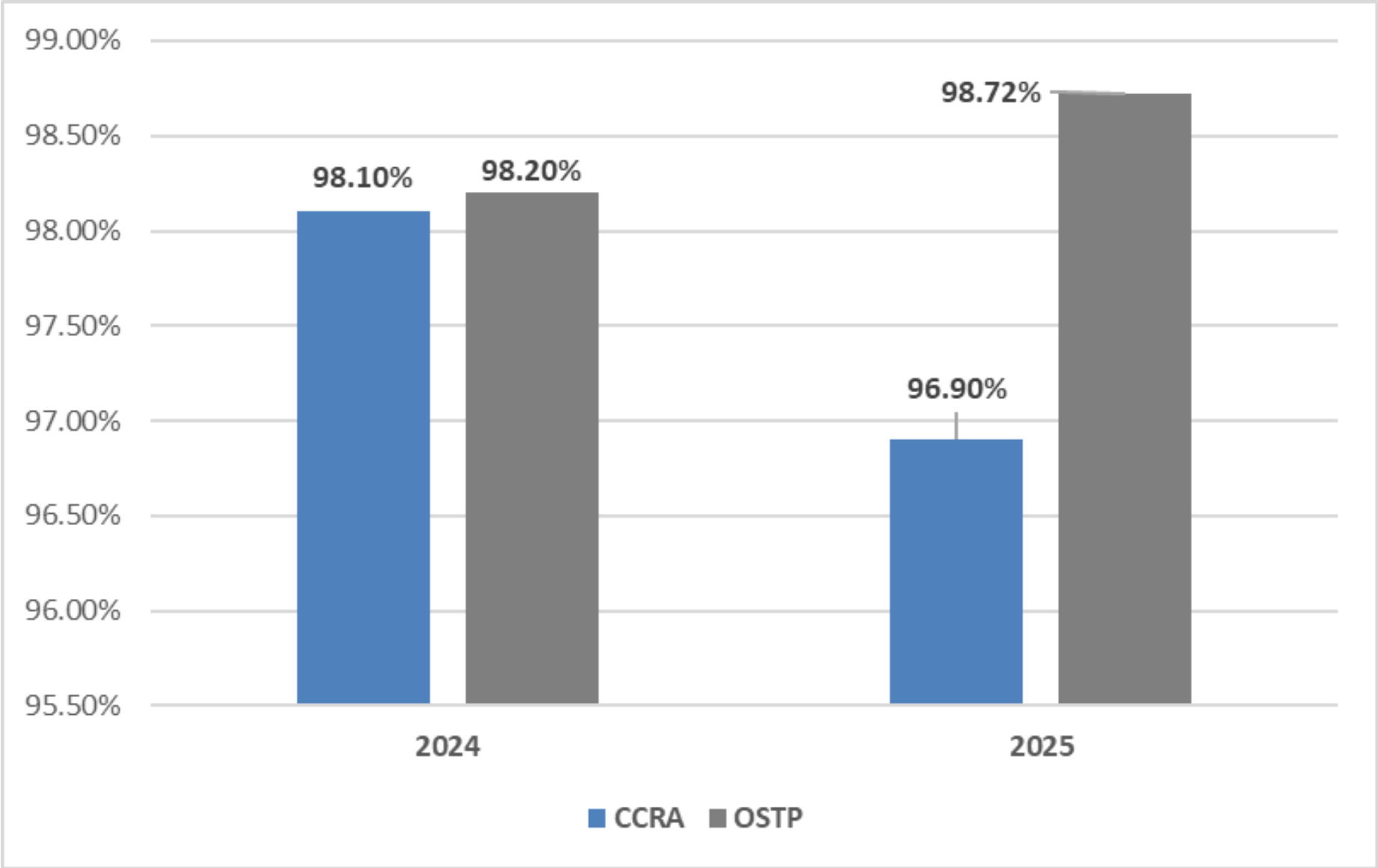

 - Breach Grade 5 Writing Prompt (125 tests scheduled with 125 completed)

 - April 21st - 25th over 455,750 tests completed

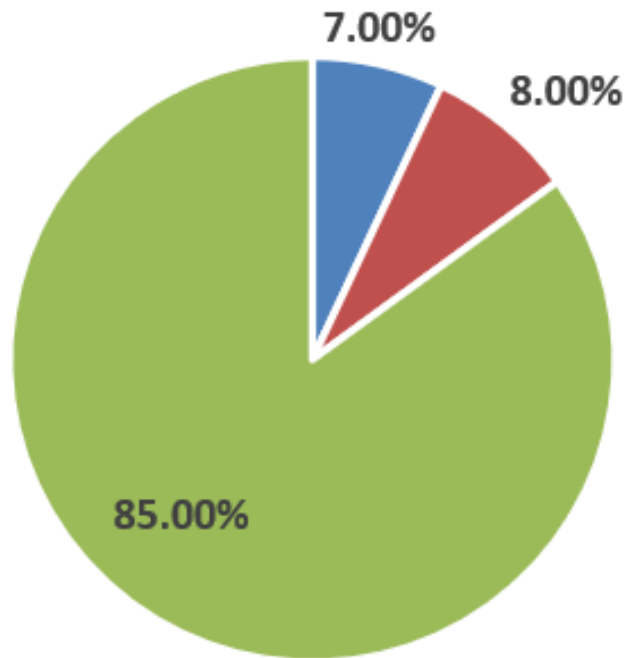

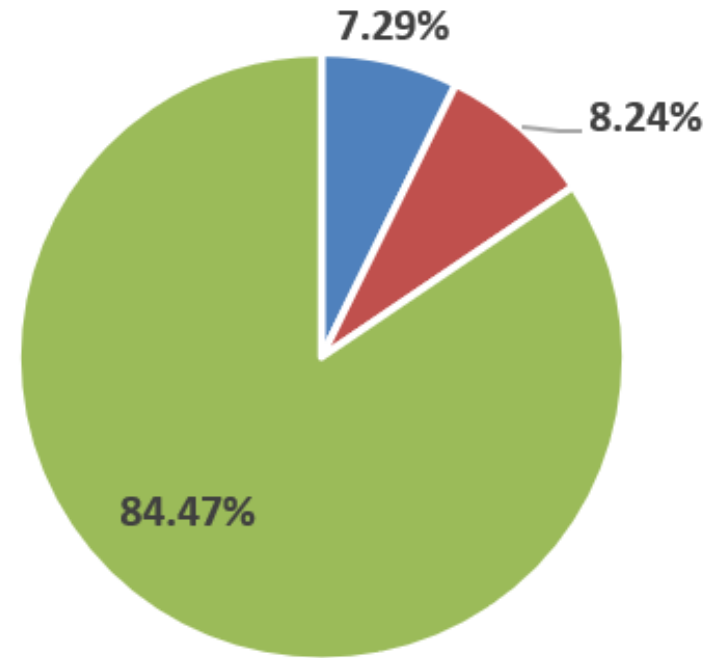
Operating System Usage

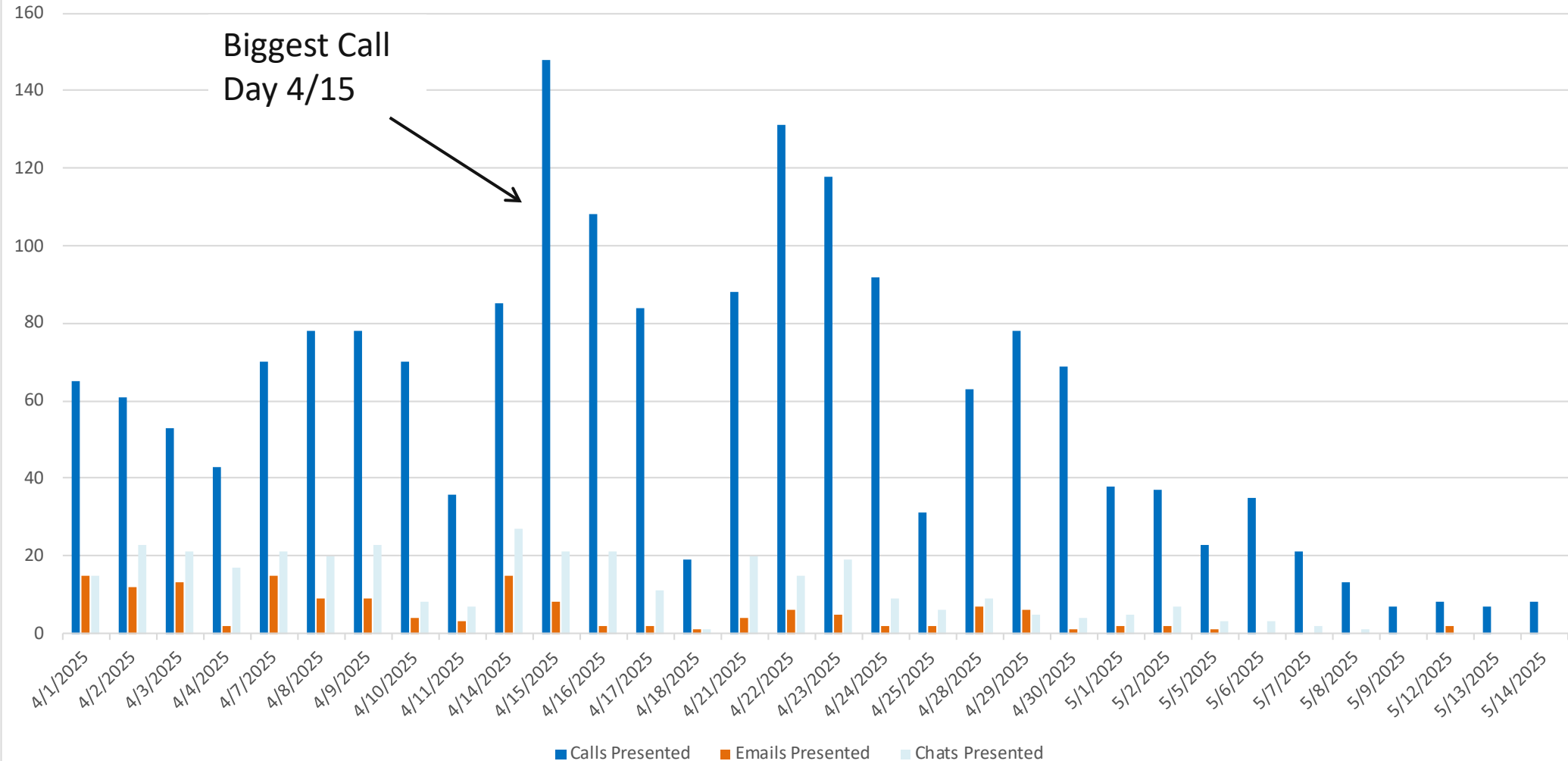

Moving Forward

- **Issue:** CCRA test administration is on a different timeline than OSTP testing, which ends before OSTP ends.

Moving Forward

- **Issue:** CCRA tests are scheduled at a course level, while OSTP tests are scheduled at a grade level (see screenshot from OSTP Data Portal User Guide page 42).

- **Moving Forward:** Please note that CCRA Science and U.S. History content tests must be scheduled at the course level in the eMetric portal for testing.

Moving Forward

- **Issue:**

- Naming a class to include an accommodation does not mean those students automatically receive their accommodations.
- Accommodations must be set before a test is scheduled to receive the proper test forms.















- **Example:**

- Class name: Smith ELA G8 WP TTS or Smith Math TTS
- Students will not receive the writing text-to-speech or the math text-to-speech form if the read aloud accommodation boxes aren't selected for them on their accommodations tab before a test is scheduled.

- **Moving Forward:** Please ensure all accommodations are set before a test is scheduled to ensure students have the correct test forms.

TA and TP Module Training Spring 2025

- Module Training Performance Statistics
 - Course were opened on February 27th-May 16th , 2025.
 - Cognia closed 28 of the 60 courses based on reaching/approaching the 1,500 maximum learners enrolled per course.
 - TAT = 20 courses closed
 - TPT = 8 courses closed
 - Enrollments = 52,402
 - Completed Certifications = 46,681
 - We peaked on March 24, enrolling 5,063 learners on that day.
 - This equals 211 enrollments per hour of 3.5 enrollments per minute.

ACT Fall Statistics



The ACT:

- 312 Oklahoma Schools participated in The ACT senior retake
- Over 6,800 students successfully tested online
- 99 Paper tests were scored

WorkKeys:

- 10 Schools participated in the WorkKeys administration
- 626 tests administered
- 115 National Career Readiness Certificates issued



ACT Spring Statistics

SITES:

- 471 Oklahoma Schools administered The ACT

TESTING:

- Over 51,400 students successfully tested online
 - 389 Total Irregularity Reports logged
 - 2,680 students in those irregularity reports
 - 23 Prohibited Behaviors reports



ACT Accommodations Requests & Statistics (Fall & Spring Combined)

- 6,684 Accommodation Requests Received
 - Only 460 requests were denied
- 1,465 Requests for EL Supports
 - Only 37 of these requests were denied

Top reasons Accommodations Requests are Denied or Only Partially Approved

1. A requested accommodation conflicts with a previously or currently approved accommodation and cannot be approved.
2. The requested testing accommodation must be regularly used in the classroom for tests, and confirmed on the examinee's IEP, 504 or Official Accommodation Plan for in-school use.
3. The accommodations being requested may be provided to the examinee on a locally approved basis during the state or district-wide administration of the ACT.
4. The requested accommodation is not listed on the examinee's IEP, 504 Plan or official accommodations plan.

Email Communications

- ACT sent 12 emails from October through April
- Over 99% of our communications were delivered
- Around 60% of all communications were opened/viewed



Customer Service Statistics

- Average total HANDLE times for September – April was **13 minutes 47 seconds** per call.
- A total of **2,104** calls from Oklahoma from September to May.



Online Testing

- Overall, a very successful testing experience in Oklahoma
- Nearly all technical issues could have been prevented by completing the site readiness steps according to ACT guidelines
- 20,934 tests were successfully completed in the first test window. 28,962 in the second test window.
- Oklahoma still leads all ACT contracts with total online testing percentage



Most Common Errors	How To Avoid
3005 - Another application attempted to take control away from TestNav	Disable all automatic application launching per p. 3 of the Technical Guide.
1009 - Network Connection issue	While this can happen unexpectedly, ACT has wireless network best practices listed on p. 18 of the Technical Guide to help minimize interruption.
8026 - Unable to connect to the proctor caching computer. Please contact your administrator.	This can be detected through both the App Check and the Mock Administration.
3105 - Chromebook attempting to use app but is not in kiosk mode	Follow Chromebook setup instructions, starting on p. 20 of the Technical Guide.
8029 - App is out of date	Be sure to download the latest version. If the app is already on the student machine, check to ensure it's the latest version.
